Med-Fast Pharmacy's Match 4 Game Sweepstakes

NO PURCHASE NECESSARY

1. WHO MAY ENTER: This contest is offered and open to anyone over the age of eighteen (18). Employees, officers and directors of Med-Fast Pharmacy, Inc., its affiliates, agents, and members of their immediate family (spouse, children, siblings, parents) or persons living in the same household (whether or not related) are NOT eligible. Groups, clubs, organizations, commercial entities, and businesses are NOT eligible. By participating, you agree to these Official Rules and to all decisions of Sponsor, which are final and binding in all respects.

Only prescription medications purchased from January 2, 2010 through February 28, 2010 at participating Med-Fast Pharmacy locations will be eligible. Winners will be determined by matching the last 4 digits of the applicable Med-Fast Pharmacy prescription labels to the random Big 4 numbers drawn at 7:00 pm in the Pennsylvania Lottery Big 4 game from February 1, 2010 through February 28, 2010. All winning numbers must be received by participant prior to the drawing date of specific winning number. Winning numbers are not retroactive and winning numbers received after the date which the winning numbers were chosen are not valid and will not be awarded a prize.

5. HOW TO REQUEST A SWEEPSTAKES NUMBER BY MAIL. You may also receive a Sweepstake number by legibly hand printing your complete name, address, e-mail address, age, and the words "Med-Fast Pharmacy Match 4 Game" on a 3" x 5" note card and mailing it, along with self addressed stamped envelope (S.A.S.E.) to, Med-Fast Pharmacy Marketing Department, 2003 Sheffield Rd. Aliquippa, PA 15001. There is no limit on the number of Sweepstake numbers you may request; however, only one (1) Sweepstake number may be requested at a time in any one (1) mailing. Requests for Sweepstake numbers must be postmarked by January 25, 2010. Mechanically reproduced requests for Sweepstake numbers is not permitted. Hand-delivered requested for Sweepstakes number will not be accepted.

6. PRIZES. Grand Prize is One (1) Year of free medical prescription refills from Med-Fast Pharmacy, up to a retail price of \$2,000.00. A valid prescription from the winner's physician is required for all prescriptions. Prescriptions will be distributed through Med-Fast Pharmacy only on a refill schedule of one (1) refill per month, per prescription, until one (1) year from date of winning or until \$2,000 in retail prescription prices have accrued. The following additional prizes are also available: one (1) - 2nd place prize of a \$500.00 Med-Fast Pharmacy gift card valued at \$500.00, one (1) - 3rd place prize of a \$250.00 Med-Fast Pharmacy gift card valued at \$250.00 each, six (6) - 4th place prizes of one (1) \$40.00 Med-Fast Pharmacy gift card valued at \$40.00 each, six (6) - 5th place prizes of one (1) \$20.00 Med-Fast Pharmacy gift card valued at \$20.00 each, six (6) - 6th place prizes of one (1) \$10.00 Med-Fast Pharmacy gift card valued at \$10.00 each and seven (7) - 7th place prizes of one (1) \$5.00 Med-Fast Pharmacy gift card valued at \$5.00 each. Odds of winning any prize are approximately 1 in 10,000. Prizes are not transferrable or redeemable for cash. Med-Fast Pharmacy reserves the right to substitute a prize or portion thereof with one of equal or greater value if entire prize or a portion of a prize is unavailable. No substitution or assignment of prize is permitted. Prizes can't be combined with any other offer. **IN THE EVENT THAT THERE ARE MULTIPLE WINNERS FOR THE GRAND PRIZE, THE GRAND PRIZE SHALL BE DIVIDED EQUALLY AMONG THE WINNERS.**

7. DRAWING AND NOTIFICATION. Winners will be selected based on the winning Pennsylvania Lottery Big 4 number drawn at 7:00 pm during the month of February, 2010, with the Grand Prize winner selected on February 28, 2010. The winning numbers must match exactly as drawn in the Pennsylvania Lottery Big 4 Drawing, and it is not a winning number if the last 4 numbers match in a boxed form, meaning same numbers but not an exact match. The Grand Prize, First and Second place winners will be required to stop into a participating Med-Fast Pharmacy to complete an affidavit of eligibility and release of liability/publicity within seven (7) days of winning or the prize will be forfeited. **It is the winners' responsibility to notify Med-Fast Pharmacy if they have a winning number. Winning numbers not claimed within seven (7) days of the date of the drawing shall be deemed forfeited.**

8. PUBLICITY: Winners may be required to complete, execute and return a Liability Release and a Publicity Release prior to receipt of any award. In the event a winner fails to execute a Liability Release and a Publicity Release within seven (7) days of the winning drawing, disqualification will result. By accepting a prize, where permitted by law, winner grants to Sponsor and its agents the right to print, publish, broadcast and use, worldwide in any media now known or hereafter developed, including but not limited to the World Wide Web, at any time or times, the winner's full name, photo, picture, portrait, or other likeness, voice and indicia of persona, and biographical information as news or information, and for advertising, trade, and promotional purposes without additional compensation or consideration, and without notification, review or approval. By participating in this contest, Entrant agrees to allow Sponsor to include Entrant's name and address in a list of winners that will be available to the public on demand. Sponsor will not share any other personally identifiable information to person's requesting a list of winners unless ordered or compelled to do so by process of law.

9. DISPUTES: Sponsor shall be the sole arbiter in all matters relating to the contest and the interpretation of contest rules. Sponsor's decisions shall be final. Entry into this contest constitutes agreement by contestant to abide by these rules, as well as any other specific contest rules established by Sponsor. Entrant agrees that: (i) any and all disputes, claims and causes of action arising out of or connected with this contest or any prizes awarded shall be resolved individually and exclusively by the Court of Common Pleas of Allegheny County, Pennsylvania; (ii) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering the contest but in no event attorneys' fees; and (iii) under no circumstances will Entrant be permitted to obtain awards for and Entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the Entrant and Sponsor in connection with the contest, shall be governed by, and construed in accordance with, the laws of the Commonwealth of Pennsylvania, without giving effect to any choice of law or conflict of law rules (whether of the Commonwealth of Pennsylvania any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the Commonwealth of Pennsylvania.

10. **DISQUALIFICATION:** Sponsor reserves the right, at its sole discretion, to disqualify any individual from the contest that it finds, in its sole discretion, to be tampering with the entry process, the entry form, or the operation of the contest; to be acting, or be, in violation of the Official Rules; or to be acting in a non-sportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person or interfere in any manner with any aspect or portion of this contest.

11. **MISCELLANEOUS:** Any attempted participation by means other than those permitted by these Rules is void. Sponsor and any participating contest agencies or prize providers will not be responsible for lost gift cards. Unclaimed prizes will not be awarded. Entry contestants, by participating (and winners, by accepting a prize) release Sponsor, its parents, subsidiaries, and its respective board, partners, vendors, agents, representatives, service agencies and independent contractors, and each of their respective directors, officers, partners, employees and agents, including advertising, public relations, direct marketing and promotion agencies, from any and all liability with respect to participation in the contest and possession or use of the prize(s) awarded and also acknowledge that they did not receive any representations, warranty or guarantee, express or implied, in fact or in law, relative to any prize.
